

## Binary Software License

This Agreement is between the Faculty of Fisheries and Protection of Waters, University of South Bohemia Ceske Budejovice, a public institution of higher education *and the user of the program*. The *user of the program* is any person which installed the program on a computer.

**1. GRANT OF RIGHT:** The software program **Multi-level model of *Synechococcus elongatus* PCC 7942** provided in binary format (the “Program”) and any related documentation (the “Documentation”) are licensed, not sold, to you. The Faculty of Fisheries and Protection of Waters, University of South Bohemia Ceske Budejovice, grants you a personal, non-exclusive and non-transferable right to use the Program and Documentation, subject to the terms and restrictions of this Agreement. The Program and Documentation may be used by you, or an organization of which you are a member or employee, solely for non-commercial, educational, evaluation and/or personal use on a single computer. “Non-commercial use” means uses that are not or will not result in

This license automatically terminates if you fail to comply with its terms and conditions. Faculty of Fisheries and Protection of Waters, University of South Bohemia Ceske Budejovice may terminate this license at any time by providing you notice of such termination. Upon termination in any manner, you agree to destroy all copies of the Program and Documentation in your possession. Your obligations under Sections 3 and 8 herein shall survive and continue after any termination of this Agreement.

**6.
